CHALLENGES

Senior citizens are becoming today's homeless population.

"You shall stand up before the gray head and honor the face of an old man, and you shall fear your God: I am the Lord."

Leviticus I 9:32 ESV

"The face of American homelessness is changing — into an older one".

What is the definition of homelessness?

Those living in a place not meant for human habitation, in emergency shelter, in transitional housing, or are exiting an institution where they have temporarily resided.

Most of the individuals/families THS serves are considered to be among those described as the "Hidden Homeless". These are the individuals who live with others temporarily, couch surfing/staying

with friends, or in a single-family household with more than one family with those living in motels. Since these individuals are not easily identified, they are 'hidden' from the national statistics on homelessness.

Georgia is one of the 12 states in the United States with over 10,000 people experiencing homelessness.

These HIDDEN HOMELESS are among the

clients to whom THS Shelter offers a "bridge" to a more abundant life. These clients may be young single adults, families, or **SENIOR CITIZENS**. It has been predicted that the number of unhoused people who are 65 and older could triple by 2030.



abuse, most notably through financial abuse, predatory lending, and illegal evictions.

THS SHELTER is definitely witnessing this trend:

Since January THS has served an estimated 64 unduplicated senior citizens 55 years old or older.

The following are examples of the many cases involving homeless senior citizens whom THS has recently served with your monetary help.

CASE #1: This is the Original Texts from the following senior client:

" I Am homeless and I need

A place to stay till I can get back on my feet .I am A elder Lady alone and no place to sleep except in my car .
(Andat Tabernacle told me about the home My Name is I am 78 years old And if you can help me I
would appreciate it."
"This is I am still working with my banks and I was told by to text ya'll to see if you could help
another week for I have got to be out tomorrow. If so I would be very greatly to ya'll for what ya'll have already done for n
Thanks for everything that ya'll are doing for me
When I get on my feet I will give back to you for everything that y'all have done. May God Bless y'all "

The above text is from a very active and motivated 78- year- old was a victim of a financial scam and lost her money. Since this individual was victimized, her life has suffered a downward spiral. To date, she has lost her car and her part time job. Her credit is ruined, and she is not eligible to get into housing without a grantor even if housing were available.

With funds you provide, THS Shelter is often able to assist those who are not able to care for their own health and safety, typically due to limited fixed income, fraud, or severe mental illness. Many such clients are left to their own devices with no further assistance from family and have exhausted financial assistance from community service providers.



CASE #2:

The elderly female client seen here does not receive adequate Social Security income to meet her needs. As a result she is often left unsheltered and without sufficient food or clothing. She walks the streets during the day, which has already resulted in two

serious car accidents as a pedestrian - one leaving her with a broken pelvis and the other with a broken arm. She is also not allowed back at several shopping areas and motels due to her behavior, which can be very destructive and argumentative because of her mental issues.. THS Shelter has paid for much of her motel expenses and various other needs. As in this case, there are times when circumstances become so extreme for a client that THS volunteers often serve as advocates to obtain other services, which may include petitioning the courts to take guardianship and control finances. THS is currently in the process of a formal appeal to the courts to assist this client; however, it is a very long, frustrating process, especially if the client refuses to cooperate.



CASE #3:

The senior gentleman whose foot is pictured came to THS from the hospital. With him was his adult medical/mentally challenged son. The elderly gentleman was a severe diabetic and had already had a toe removed. The father and son had lost

their home in a fire and had been living in the woods and in and out of motels. With funds provided by you, THS walked alongside them for several weeks helping with shelter and food, seeing they got to appointments, and assisting in acquiring needed documents. During this time there were many trips and stays at the hospital. Eventually the father ended up in another hospital. where his foot was removed and shortly afterward he passed away.

We have learned that the son is now living close to a sister in a building not fit for habitation. THS is in touch with the needy sister and does what we can to offer assistance.

Prayer: Lord, help us to be open to the challenge of helping others.

If it were not for you, our giving community, THS Shelter would not be able to offer services to help bridge those in need to a more abundant life in Jesus Christ.

SUCCESSES

You helped THS with the resources to provide this **senior** adult client with shelter, food, hygiene, and clothing while provisions were being made to place her in a state assisted program. This process was accomplished by partnering with Carrollton Police



Department, Carroll Mental Health Advocacy, and the Soup Kitchen. Otherwise, this elderly woman might have continued to be on the streets.

OTHER SENIOR CITIZENS SUCCESS CASES

Through the persistent efforts of two dedicated volunteers who made countless phone calls as well as numerous trips, THS Shelter was also able to assist two other senior clients with residence in personal care homes.

THS volunteers assisted another senior client in finding residence in a local housing facility. Volunteers also helped with his down payment, and physically helped to move the client into the facility.

While THS has aided a number of senior citizens, we have also helped others in need. We are happy to share the following two success stories:



Case #1 Client quote: With your financial support THS Shelter was able to help Michael with an eye exam and special prescription glasses so he could start a new job. Thank you for the funds received to make this possible.





THS is so happy for this couple. Their major

need now is a car so they can get back and forth to work.

CASE #2: With your help THS has assisted this couple with shelter, clothing, and food. Recovering addicts, they both attend CMHA for mental health support and have both found employment. They have joined Freedom Point Church, been baptized, and are attending classes at Pathways. We recently celebrated with them the passing of a drug test that is required for them to be awarded visitations with their children. They are scheduled to move into their own apartment in August.

SPOTLIGHT OF VOLUNTEERS

From January to June of this year approximately 30 dedicated volunteers have served over 200 hours a week for THS Shelter. With the new efforts of THE CONNECTOR project, we anticipate the on-going need for additional volunteers. PAST or PRESENT

with our founding in 2014 as an overnight shelter, we soon added several in-house programs.

Then COVID...

"In their hearts, humans plan their course, but the Lord establishes their steps." Proverbs 16:9

Together with your financial help and prayers, we learned new ways to arrange and pay for services by phone. We continue today to operate with a system of text /emails questionnaires and phone interviews. This allows us to provide appropriate financial benevolence and informed counsel, along with referrals to other agencies.

With your support in the first six month period of 2023, THS has served approximately 550 unduplicated adults and 200-plus unduplicated children. We estimate that in 2023 we will serve over 1,200 unduplicated adults and 350-plus unduplicated children.

As noted earlier in the letter senior citizens are the rising population of those experiencing homelessness. In the first six months of 2023 THS served 31 unduplicated senior individuals 60 years old or older.

Since we are an all volunteer, 501(c)3 agency, over 92% of our budget goes to direct client services. In the first 6 months of 2023, 64% of THS benevolent expenses went to pay motel costs, 17% for rent, 7% for utilities, and 12% to other needs (transportation, phone service, clothing, food, laundry, personal documents, etc.)

FUTURE

THS is proud to announce that we have been working with Community Foundation of West Georgia along with other non-profits in West Georgia to implement THE CONNECTOR!

The Connector is a central hub that will quickly connect those in need with services. For detailed information about the Connector Project visit, www.cfwg.net.

Through this effort, we envision helping Carroll, Heard and Haralson Counties to:

- Clarify community resources and best services access points
- Offer a single point of request, via on-line, phone or in person, streamlining the process when seeking help
- Provide client with what they need, when they need it to help support paths of self sufficiency
- Create a collaborative and cooperative model between service providers to allow efficient

service delivery

 Provide a user-friendly data portal, accessible by all service providers, connecting member agencies through data share

Connecto

- Leverage data collected from clients and partner agencies (as they address needs) to better understand trends of needs and solutions
- Establish a foundation for a future community model to support thoughtful and intentional change





Bill Brown

Johnny Lemont Parker

On June 11,2023, a Celebration of Life service was held in memory of Johnny Parker, a guest/client of THS Shelter since its founding in 2014. When THS was able to secure his Social Security Disability and a stable living environment, Johnny commented that it was his first home other than a jail, a rehab facility or a shelter that he'd had since he was a child. While Johnny's life was far from easy, his faith in Christ Jesus never faltered.



Joe Foreman


